Re: February 2021 HMIS Monitoring Reports (Neighbor Islands – Bridging the Gap)

Attached for your review and dissemination to Continuum agencies is the February 2021 HMIS monitoring report. Below are brief highlights from the attached reports.

1. End of month, February 2021 Census summary by Continuum and Statewide (pp. 2-5)
 - The Neighbor Island census for emergency shelter (ES) and transitional housing (TH) programs increased in February 2021 (607), compared to January (578), with an increase in both ES and TH.
 - The total “vacant beds” compared to the HIC bed capacity was 386 (ES and TH) and 63 (permanent supportive housing – PSH). This is a decrease for all programs compared to last month. HIC openings can also vary depending on differences in household size.
 - 31 programs on the Neighbor Islands had utilization rates of less than 85% or greater than 110%. These programs are marked in red.
 - Active outreach clients totaled 500, an increase compared to December 2020 (483 clients).
2. Consent report for February 2021 (pp. 6-12)
 - VI-SPDAT Assessments: Consent to share data rate for Neighbor Islands was 97%, the same rate as in January.
 - By Name List consent to share data rate as of the 03/01/21: BNL cut was 99% for the CoC, the same rate as in January.
 - For adult program intakes entered in February 2021 (n=293), the Neighbor Islands consent to share data rate was 98%, one percentage point higher than in January (97%).
 - For February intakes, three programs had consent rates of 80% or below.
3. Length of stay (LOS) by agency and program for clients exiting during February 2021 (pp. 13-15)
 - The average LOS over all programs was 138 days (representing 227 exits), a decrease compared to January 2020 (142 days); February’s LOS was lower than the 12-month average for Neighbors Islands LOS (140 days) from March 2020 – February 2021.
 - This month, excluding PSH, the average LOS was 132 days.
 - Homeless Prevention and Street Outreach programs’ LOS were the shortest (87 and 114 days). Permanent Supporting Housing and Transitional Housing programs’ LOS were the longest (371 and 370 days).
 - By County, Hawaii (160) averaged the longest LOS, followed by Maui (146 days), and Kauai (77 days).
 - Emergency shelter average LOS ranged from 32 days on Kauai to 163 days on Maui.
 - Transitional housing average LOS ranged from 566 days on Hawaii to 173 days on Kauai.
4. Timeliness (entries and exits) during February 2021 (pp. 16-19)
 - Intake timeliness increased to 2.07 average days, from 1.34 average days in January.
 - Five programs (highlighted in RED) averaged more than 3 days to enter intakes.
 - Exit timeliness increased to 1.97 average days, compared to 0.71 average days in January.
 - Ten programs (highlighted in RED) averaged more than 3 days to enter exits.

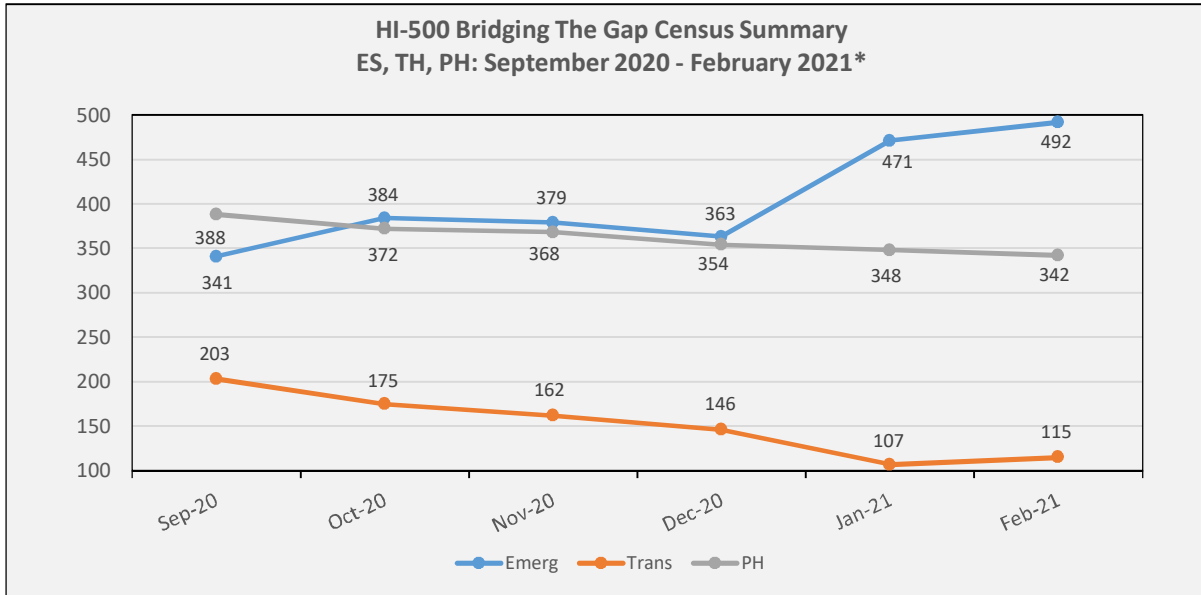

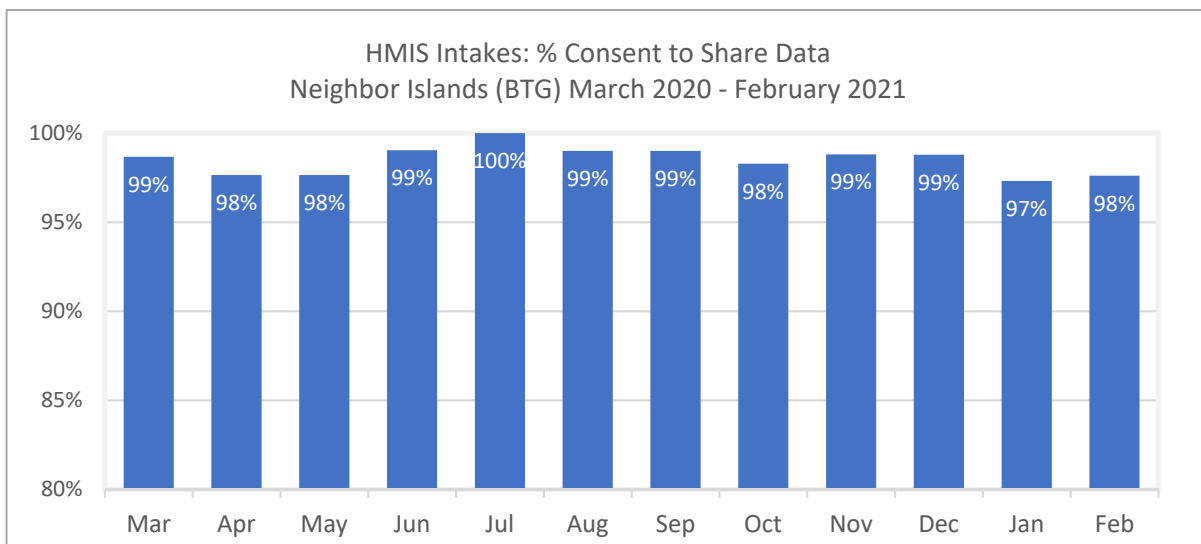
