Re: July 2020 HMIS Monitoring Reports (Neighbor Islands – Bridging the Gap)

Attached for your review and dissemination to Continuum agencies is the July 2020 HMIS monitoring report. Below are brief highlights from the attached reports.

1. End of month, July 2020 Census summary by Continuum and Statewide (pp. 2-4)

- The Neighbor Island census for emergency shelter (ES) and transitional housing (TH) programs increased in July 2020 (557), compared to June (519), with an increase in ES, but a decrease in TH.
- The monthly combined census (ES, TH, PSH) has fluctuated over the past year from a high of 982 in February 2020 to the current low of 911 in June.
- The total "vacant beds" compared to the HIC bed capacity was 3254 (ES and TH) and 88 (permanent supportive housing PSH). This is a decrease for all three programs compared to last month. HIC openings can also vary depending on differences in household size.
- 18 programs on the Neighbor Islands had utilization rates of less than 85% or greater than 110%. These programs are marked in red.
- Active outreach clients totaled 389, a decrease compared to June 2020 (420 clients).
- 2. Consent report for July 2020 (pp. 5-10)
 - VI-SPDAT Assessments: Consent to share data rate for Neighbor Islands was 98%, two percentage points lower than the past two months (100%).
 - By Name List: consent to share data rates as of the 8/01/20, BNL cut was 99% for the CoC. July rates included: 100% for Hawaii singles, Kauai families and singles and Maui families; 99% for Maui singles and 98% for Hawaii families.
 - For adult program intakes entered in July 2020 (n=273), the Neighbor Islands consent to share data rate was 100%, the same as last month.
 - For July intakes, no programs had a consent rate below 80%.
- 3. Length of stay (LOS) by agency and program for clients exiting during July 2020 (pp. 11-12)
 - The average LOS over all programs was 145 days (representing 318 exits), a slight decrease compared to June 2020 (146 days), but higher than the seven-month average for Neighbors Islands LOS (133 days) from January July 2020.
 - Excluding PSH, the average LOS was 133 days.
 - ES and Homeless Prevention programs' LOS were the shortest (92 and 104 days). PSH and TH programs' lengths of stay were the longest (549 and 245 days).
 - By County Maui (149) averaged the longest LOS, followed by Hawaii (146 days) and Hawaii (118 days).
 - Emergency shelter average LOS ranged from 48 days on Kauai to 149 days on Maui.
 - Transitional housing average LOS ranged from 459 days on Hawaii to 150 days on Maui.
- 4. Timeliness (entries and exits) during July 2020 (pp. 13-15)
 - Intake timeliness was 2.11 average days, an increase compared to 1.58 average days in June.
 - 17 programs (highlighted in RED) averaged more than 3 days to enter intakes.
 - Exit timeliness increased to 2.00 average days, compared to 1.30 average days in June.
 - 14 programs (highlighted in RED) averaged more than 3 days to enter exits.




