Re: November 2020 HMIS Monitoring Reports (Neighbor Islands – Bridging the Gap)

Attached for your review and dissemination to Continuum agencies is the November 2020 HMIS monitoring report. Below are brief highlights from the attached reports.

1. End of month, November 2020 Census summary by Continuum and Statewide (pp. 2-5)

- The Neighbor Island census for emergency shelter (ES) and transitional housing (TH) programs decreased in November 2020 (541), compared to October (559), with a decrease in both ES and TH.
- The total "vacant beds" compared to the HIC bed capacity was 434 (ES and TH) and 42 (permanent supportive housing PSH). This is an increase for ES and TH, and a decrease for PH programs compared to last month. HIC openings can also vary depending on differences in household size.
- 32 programs on the Neighbor Islands had utilization rates of less than 85% or greater than 110%. These programs are marked in red.
- Active outreach clients totaled 468, a decrease compared to October 2020 (487 clients).
- 2. Consent report for November 2020 (pp. 6-11)
 - VI-SPDAT Assessments: Consent to share data rate for Neighbor Islands was 98%, one percentage point less that in October (99%).
 - By Name List consent to share data rate as of the 11/30/20 BNL cut was 99% for the CoC, the same rate as in October.
 - For adult program intakes entered in November 2020 (n=250), the Neighbor Islands consent to share data rate was 99%, one percentage point higher than in October (98%).
 - For November intakes, one program had a consent rate of 80% or below.
- 3. Length of stay (LOS) by agency and program for clients exiting during November 2020 (pp. 12-14)
 - The average LOS over all programs was 124 days (representing 311 exits), a decrease compared to October 2020 (152 days); November's LOS was lower than the 11-month average for Neighbors Islands LOS (137 days) from January November 2020.
 - This month, excluding PSH, the average LOS was 123 days.
 - Homeless Prevention and Emergency Shelter's LOS were the shortest (102 and 111 days). Services only and Transitional Housing program's LOS were the longest (331 and 282 days).
 - By County, Hawaii (168) averaged the longest LOS, followed by Maui (125 days) and Kauai (59 days).
 - Emergency shelter average LOS ranged from 39 days on Kauai to 133 days on Maui.
 - Transitional housing average LOS ranged from 104 days on Kauai to 326 days on Maui.
- 4. Timeliness (entries and exits) during November 2020 (pp. 15-18)
 - Intake timeliness decreased to 1.52 average days, from 1.77 average days in October.
 - 10 programs (highlighted in RED) averaged more than 3 days to enter intakes.
 - Exit timeliness increased to 2.14 average days, compared to 0.99 average days in October.
 - 17 programs (highlighted in RED) averaged more than 3 days to enter exits.




